### **Naropa University Disclosure**

*Notice to students pursuing the Clinical Mental Health Counseling M.A., which may lead to a professional license or certification required for employment.*

*This document is effective 8/19/26 and replaces any previously published or distributed versions of the document.*

Professional licensure and/or certification requirements vary from state to state, which may affect a student's ability to secure a professional license or certification upon the completion of the program. The U.S. Department of Education regulation 34 CFR 668.43(a)(5)(v) requires an institution to disclose whether or not the program will fulfill educational requirements for licensure or certification in each state.

The Naropa University education combines rigorous academic learning with contemplative practice. Naropa's CMHC program is designed to meet state educational requirements for licensure. In Colorado, the State Board of Licensed Professional Counselor Examiners (DORA) has evaluated our curriculum and designated the program as meeting Colorado's educational standards for LPC licensure, allowing our graduates to bypass the individual course-by-course education review when applying in Colorado. The CMHC M.A. program is currently structured to align with national CACREP standards. This means that we teach all the core components that are required by CACREP to be a Clinical Mental Health Counselor, in addition to leading-edge contemplative mindfulness, and mind/body integration tools.

If you are a graduating student, we strongly encourage you to start the process of applying for professional licensure in the state you intend to practice in prior to leaving Naropa.

Licensure application approval is determined solely at the discretion of each jurisdiction's licensing board and any guidance provided by Naropa University or its employees is not a guarantee of licensure approval or acceptance of education to meet requirements. If you'd like to further explore licensure, you may use the links provided per state to contact the state licensure boards.

The following chart discloses Naropa University's determinations on whether our concentrations meet the educational requirements for licensure in each state. The chart also indicates our determinations on whether the curriculum meets the educational

requirements for *provisional licensure only* in those states where applicable. States with an asterisk\* after “yes” indicate that Naropa meets education requirements for *provisional licensure*. After reviewing Naropa’s audit of additional state requirements, students must follow up with the respective state licensing board to confirm the full licensure requirements beyond the provisional level. Please note that states marked ‘yes’ for provisional licensure may also have additional clinical placement requirements. Students can reference additional requirements in the Supplementary Section under the Licensure Updates & Disclosures heading on the L/C SharePoint page.

*In this assessment, references to a “state” shall be interpreted to include U.S. territories, encompassing all 51 states (includes the federal district of D.C.) and four U.S. territories.*
